Library Structure overview

The Library Administration recently restructured its departments. There are now three divisions: Community Libraries, Equitable Libraries, and Library Logistics. These are overseen by Division Directors Ramses Escobedo (Community Libraries), Erin Berman (Equitable Libraries), and Ben Gomberg (Library Logistics).

System Coordination Role

Within the new Library structure, there are five Librarian IVs (three in Equitable Libraries and two in Library Logistics) whose roles are focused on systemwide function.

The Library Lockers located at Wally Pond and Warm Springs Community Center soft launched on the 14th. The goal is to test out the service, get feedback, and make improvements before the full launch.

Youth Poet Laureate

Alameda County's annual Youth Poet Laureate competition returns for its 5th year and runs from April 1st-30th.

Our inaugural Youth Poet Laureate, Zoe Dorado (2021) was named Vice Youth Poet Laureate for the United States in 2024 during a ceremony at the Kennedy Center.

During our inaugural competition, a young man detained at the Alameda County Juvenile Justice Center was named Alameda County Vice Youth Poet Laureate - a nationwide first.

Youth have read at various County and City Events: AC Women's Hall of Fame, Poetry Programs, Pride Events, and much more

Current Alameda County Youth Poet Laureate, Jovina Zion Pradeep, has been named the West Regional Youth Poet Laureate and is in the running to become the Youth Poet Laureate for the United States.

Advisors Give Back

This new program connects library members to free online appointments with financial advisors.
